Please read these instructions carefully and follow them closely to ensure that the review and publication of your paper is as efficient and quick as possible. The Editors reserve the right to return manuscripts that are not in accordance with these instructions.

All material to be considered for publication in The Review of Economic Studies should be submitted in electronic form via the journal's online submission system at <http://editorialexpress.com/restud>, where you will be guided through a simple and secure procedure which will enable you to upload your paper, along with any supporting material, and also enter or update your personal details

The Review of Economic Studies will publish papers only if the data used in the analysis are clearly and precisely documented and are readily available to any researcher for purposes of replication. Authors of accepted papers which contain empirical work, simulations, or experimental work, must provide to the Review, prior to publication, the data, programs, and other details of the computations sufficient to permit replication. These will be posted on the Review of Economic Studies web site. We reserve the right to refuse publication of papers whose authors do not comply with these requirements.

## DATA

As soon as possible after acceptance, authors are expected to send their data, programs, and sufficient details to permit replication, in electronic form, to the Review office. ## MANUSCRIPT FORMAT AND STRUCTURE

Authors should upload a single pdf-file containing the complete manuscript (i.e. title page, abstract, text, figures and tables), as this makes the reviewing process easier for Editors and referees. This applies to the original version of the manuscript and any revised versions. Due to figure file size constraints, you may have to submit separate files for figures. The location of Tables and Figures should be indicated in the text.

Please also include the files for any other supplementary material to be submitted with your manuscript. It is recommended that authors spell-check all files before submission.

The first page of the manuscript must give: title of paper, contributor names, and the full address (including email) of the author designated to receive proofs/correspondence. An abstract of no more than 150 words should be included with all submissions. The name of the author(s) should appear at the beginning immediately under the title, with an asterisked footnote giving the present position of the author(s) and an address (including email) for contact by readers, together with any desired acknowledgements. Headings should be to journal style. Compound words should be hyphenated. Authors are responsible for checking the accuracy of all

**Introduction**

Michelangelo Merisi (b. 1571–d. 1610) was one of the founders of the Baroque style. His extraordinary nature of his art and the lurid details of his life. After an apparently unfinished apprenticeship in Milan, Caravaggio moved to Rome. Initially, he struggled to establish a career, but with one of the city's most successful painters, the Cavaliere d'Arpino, but he was then patronized by Cardinal Francesco Maria Del Monte. Under his patronage, Caravaggio developed a new style rooted in naturalistic observation and the use of tenebrism (strong contrasts of light and shadow), which rejected the prevailing values of mannerist artists, such as the Cavaliere. At first he painted genre works, particularly ambiguous works about young boys accompanied by still-life objects. Primarily a painter of religious works, his first public works were highly acclaimed, such as the decoration of the Contarelli Chapel in San Luigi dei Francesi (1599–1602) and of the Cerasi Chapel in the Vatican Museums.

## The Madonna dei Palafrenieri

The last major altarpiece that Caravaggio painted in Rome, this was intended for a chapel in St. Peter's. However, it stayed there only for a few days before being removed and sold to the papal nephew, Cardinal Scipione Borghese, in whose villa the painting still remains. There has been much speculation as to the reasons for the painting's removal, whether for lack of decorum or other reasons, as seen in [Spezzaferro 1974](#) and [Spezzaferro 1998](#). The painting was restored in 1998 ([Coliva 1998](#)).
