DCT Gdansk is Poland's largest and fastest developing container terminal, majority owned by GIF II (Global Infrastructure Fund II), a specialized fund managed by a member of the Macquarie Group of Companies, headquartered in Australia.

DCT was the first terminal that attracted shipping lines to deploy direct shipping services from Asia to the Baltic Sea and is today the destination for the largest vessels in the world departing from Korea and China. This process initiated a split of the most important shipping trade-lane in the world, Asia - Europe, into Asia - North Europe and Asia - Baltic. The Terminal offers year-round ice -free access with a 17.0m deep approach channel and up to 16.5m depth along the berth. The rail terminal, 2 x 1000m long and operated by DCT Gdansk, is adjacent to the marine facility. DCT Gdansk is an ideal gateway to Poland and Central-Eastern Europe countries, as well as a transshipment hub for Russia and the rest of the Baltic region. DCT Gdansk - more
