## **Success of the 11th Annual BMDA Conference!**

Starting May 8th until May 10th, 2013 the participants of 11th BMDA Annual Conference "The Role of Management Empowering Innovations and Creativity" were enjoying various events of Pre-Conference and Conference activities.

11th Annual BMDA Conference took place on May 9th-10th in Kaunas and was hosted by Kaunas University of Technology. It was attended by 123 participants from 16 countries! International Academic and Business community gathered together in Kaunas for a few days were the issues of management role for sustainable innovations and creative solutions have been explored.

The Conference started with few Pre-Conference activities on May 8th.

First one was "Meeting of International Research Ideas" dedicated for Researchers. During the Meeting Publishers and Chief Editors of the five prestigious journals along with the representatives of Euromonitor International gave their insights and ideas how to prepare high quality research paper. After presentations participants joined roundtable discussions with the speakers.

Another additional Pre-Conference event was between two management development associations - BMDA and Russian Association for Business Education (RABE) gathered together for the first joint Conference "From Cooperation to Partnership". The Conference was hosted by ISM University of Management and Economics in Vilnius.

During this Conference members of both associations, represented by Rectors, Deans and Directors of various business schools from Russia, Lithuania, Latvia, Estonia, Kazakhstan and Ukraine, shared their insights on how to find mutually beneficial conditions for long term sustainable partnership among various business schools in the Region and beyond.

During the last session of the Conference, which was moderated by president of BMDA Dr. Virginijus Kundrotas and RABE president Prof. Sergey Miasojedov, a number of joint activities (summer schools, joint projects, joint virtual portal, etc.) had been defined and the agreement to start on the implementation of those decisions have been made.

The Main part of the Conference started on the morning of May 9th with the Research part where 27 research papers were presented by the authors.

All the Conference was chaired by Prof. Rolf D. Cremer (the Dean Emeritus of CEIBS, China, Former President of EBS University for Business and Law, Germany).

During the first day of the event the presentations were delivered by the outstanding keynote speakers such as prof. Soumodip Sarkar (Dean of Institute for Advanced Studies and Research, Evora University, Portugal), Mr. Lauri Koponen (Sales Director at JSC ACME Europe, Finland) and prof. Peter Lorange (President/CEO at Lorange Institute of Business Zurich, Switzerland).

Later, Conference participants took part in the CEO Panel discussion actively debating what Business and Academia could do together in order to succeed, create and sustain their innovative approach.

Further, BMDA President Dr. Virginijus Kundrotas presented BMDA activities for year 2013 and the Conference was finalized by inspiring speech of prof. David K. Hurst about "The New Ecology of Leadership" that encouraged Conference participants to think "out of the box". Conference was closed enjoying a nice evening, dances and networking during Gala dinner.

All in all, this Conference was the place for debate and dialogue, the platform for exchanging experiences, and the meeting place for all parties involved in innovations and strategic development as well as experiencing joyful moments together!

#### RTU FEEM STUDY TRIP TO BRUSSELS



During the last two months the students of Riga Technical University, Faculty of Engineering Economics and Management have had opportunities to participate in two study trips abroad. The study trips have helped the students gain international experience, new knowledge and contacts. One of the study trips was organized to Brussels. That was the annual study trip for the students of **Bachelors and Masters** study program "Organization and Management of International Economic Relations" organized by the administration of the study program.

FEEM students were in Brussels from March 18th to 22nd, 2013. They had an opportunity to visit and learn about the institutions of the European Union. The study trip is an integral part of the program that allows the students to combine their theoretical knowledge, with practical experience.

In Brussels, the students visited a number of institutions: the European Commission, the European Parliament, the European Economic and Social Committee, the Permanent Representation of the Republic of Latvia to the European Union and the Latvian Em-

bassy in the Kingdom of Belgium and the Grand Duchy of Luxembourg. The students also visited some local businesses in Brussels.

At the European Commission the students had an opportunity meet the Commissioner for Development and learn about his work. During the visit to the Commission students also attended three lectures on the following topics: "Trade policy: the EU current agenda"; "Europe at the lead of the new industrial revolution" and "Competiton policy".
